Details of the goose hunt weekend are as follows:

We will be hunting on September 24<sup>th</sup>.

Youth 12-15 years of age, must have a small game hunting license and HIP Number.

Youth and Women ages 16 and up must have a small game hunting license hunting, Federal Waterfowl Stamp, and a HIP number.

The youth will need to have the proper ammunition for this hunt. They must have Steel or Non-Toxic shot (No Lead Shot allowed). A recommendation for ammunition is at least # 2 or BB size shot for this hunt.

On the Safety Day we will be supplying the ammunition that will be used that for that day

On the back side of this form is a checklist that we would like for the youth to fill out. These are suggested items that they may need to go hunting. It is not required that they have these items when they show up for safety day or for the hunt. We are just trying to get an idea what they do have.
