Youth must attend the Safety Day starting at 9 AM to be held at the Cassety Hollow Rod & Gun Club located on Alabam Rd. Oriskany Falls, NY 13425. **The Date is April 13th 2024**

Details of the youth turkey hunting weekend are as follows:

Eligible hunters are youth 12-15 years of age, holding a junior hunting license & turkey permit; Youth 12-13 years of age must be accompanied by a parent, legal guardian or relative over 21 years of age, with written permission from their parent or legal guardian.

Youth 14-15 years of age must be accompanied by a parent, legal guardian or an adult over 18 years of age, with written permission from their parent or legal guardian;

Shooting hours are one-half hour before sunrise to noon each day; and

The bag limit for the youth weekend is one bearded bird. This bird becomes part of the youth's regular season bag limit of 2 bearded birds. A second bird may be taken beginning May 1. All other turkey hunting regulations are in effect that weekend.

On the back side of this form is a checklist that we would like for the youth to fill out. These are suggested items that they may need to go hunting. It is not required that they have these items when they show up for safety day or for the hunt. We are just trying to get an idea what they do have.
